INSTRUMENTO DE ALTERAÇÃO CONTRATUAL celebrado entre o BANCO INTERAMERICANO DE DESENVOLVIMENTO (a seguir denominado “Banco”) e o ESTADO DO PARANÁ (a seguir denominado “Mutuário”), com a interveniência da REPÚBLICA FEDERATIVA DO BRASIL (a seguir denominada “Fiador”).

ARTIGO PRIMEIRO

Ficam introduzidas as seguintes modificações no Contrato de Empréstimo 4632/OC-BR, (a seguir denominado “Contrato”), celebrado entre o Banco e o Mutuário em 16 de abril de 2020, e posteriormente modificado em 31 de janeiro de 2024, para cooperar na execução do Programa Estadual de Apoio ao Desenvolvimento Urbano e Melhorias de Infraestrutura Municipal – Paraná Urbano III (a seguir denominado “Programa”):

1. O texto da Cláusula 2.04 das Disposições Especiais do Contrato passa a vigorar com a seguinte redação:

“**CLÁUSULA 2.04. Prazo para desembolsos.** O prazo para desembolsos será até 16 de abril de 2027. Qualquer prorrogação deste prazo deverá contar com a anuência do Fiador e estará sujeita ao previsto no Artigo 3.02(g) das Normas Gerais.”

2. O texto do parágrafo 4.03 do Anexo Único do Contrato passa a vigorar com a seguinte redação:

“**4.03.** As atividades compreendidas no Componente I serão financiadas com recursos de Contrapartida Local, por meio de empréstimos da Fomento Paraná aos municípios beneficiários do Programa ou de aportes de recursos não reembolsáveis do Mutuário. As atividades compreendidas no componente II serão executadas por intermédio de empréstimos da Fomento Paraná aos municípios beneficiários do Programa. Os recursos a serem utilizados para esses empréstimos provirão da capitalização da Fomento Paraná, que efetuará o Mutuário com recursos do Programa.”

3. O texto do parágrafo 4.04 do Anexo Único do Contrato passa a vigorar com a seguinte redação:

“**4.04.** A execução dos projetos compreendidos nos componentes I e II será realizada em conformidade com o previsto neste Contrato e no ROP. Os projetos compreendidos no Componente I poderão ser executados pelos municípios beneficiários do Programa ou pelo Órgão Executor. Os projetos compreendidos no Componente II serão executados pelos municípios beneficiários do Programa.”

ARTIGO SEGUNDO

Para os efeitos deste Instrumento de Alteração Contratual, os termos iniciados com maiúsculas utilizados neste Instrumento de Alteração Contratual terão os respectivos significados a eles atribuídos no Contrato.

ARTIGO TERCEIRO

Ratificam-se as demais disposições do Contrato de Empréstimo Nº 4632/OC-BR, o qual permanece em pleno vigor, com as alterações que constam no Artigo Primeiro deste Instrumento de Alteração Contratual.

ARTIGO QUARTO

O Fiador manifesta expressamente sua integral concordância com todas as disposições deste Instrumento de Alteração Contratual.


